
## 6808HDxl Quick Start Guide



## Step 1: Check what's in the box



6808HDxI HD/SD-SDI AES De-embedder








Save the original box and packaging materials in case you need to return your 6808HDxI for service.

## Step 2: Install the 6808HDxl

Attach the rubber feet and place on a table or mount the 6808HDxI in a rack (using an optional RK-3T rack adapter).

## Step 3: Connect the inputs and outputs

Always switch off the power on each device before connecting it to your 6808HDxI.



Always use Kramer high-performance cables for connecting AV equipment to the 6808HDxI.

## Step 4: Connect the power

Connect the 5V DC power adapter to the 6808HDxI and plug the adapter into the mains electricity.



## Step 5: Operate the 6808HDxl

By default, the GROUP SELECT DIP-switches are set to group 1.



Set the DIP-switches to choose the group to de-embed.

For example, setting DIP 1 to ON de-embeds the two audio channels from group 1.

## 2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables (we recommend Kramer highperformance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality
- Position your Kramer 6808HDxI away from moisture, excessive sunlight and dust



This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.

## 3 Overview

The 6808HDxl is a high-performance audio de-embedder for 3G HD-SDI video signals. The unit can de-embed two selectable AES audio streams.

### The 6808HDxI features:

- A maximum data rate of 3Gpbs
- 1 SDI input and 1 SDI output on BNC connectors
- · AES-3id outputs on BNC connectors
- Group select DIP-switches to choose the group to de-embed
- Kramer reKlocking™ & Equalization Technology that rebuilds the digital signal to travel longer distances
- Status indicators: SD/HD lock and power LEDs
- 5V DC power

## 3.1 Defining the 6808HDxl HD/SD-SDI AES De-Embedder

This section defines the 6808HDxI.




Figure 1: 6808HDxl HD/SD-SDI AES De-Embedder

1	HD/SD-SDI IN BNC Connector	Connects to the SDI source	
2	HD/SD-SDI OUT BNC Connector	Connects to the SDI acceptor	
3	AES OUTPUT A	Connects to AES acceptor 1 (channel 1)	
4	AES OUTPUT B	Connects to AES acceptor 2 (channel 2)	
5	5V DC	+5V DC connector for powering the unit	
6	LOCKLED	Illuminates green when an SD signal is detected or blue when an HD signal is detected	
7	GROUP SELECT DIP-switches	Selects the audio group to de-embed (from 1 to 4)	
8	ON LED	Illuminates green when the power is connected

## 4 Connecting the 6808HDxI



Always switch off the power to each device before connecting it to your **6808HDxI**. After connecting your **6808HDxI**, connect its power and then switch on the power to each device.

To connect the 6808HDxI as illustrated in the example in Figure 3:

- Connect an SD/HD/3G HD-SDI source (such as an HD/SD digital video player) to the HD/SD-SDI IN BNC connector.
- Connect the HD/SD-SDI OUT BNC connector to an SDI acceptor (such as an SDI display).
- Connect the AES OUTPUT A BNC connector (for channel 1) to AES digital audio acceptor 1 (such as DAT-Recorder 1).
- Connect the AES OUTPUT B BNC connector (for channel 2) to AES digital audio acceptor 2 (such as DAT-Recorder 2).




Figure 2: Group Select DIP-Switches

- Set the GROUP SELECT DIP-switch ON for the group to de-embed (from 1 to 4). Figure 2 shows group 1 selected.

Note: Set one switch ON only. Set all other switches OFF.




Figure 3: Connecting the 6808HDxl HD/SD-SDI AES De-Embedder

Connect the 5V DC power adapter to the power socket and connect the adapter to the mains electricity (not shown in <u>Figure 3</u>).

**Note**: Each audio group in an SDI signal contains four mono channels, thus the SDI stream carries a total 16 mono channels. Each AES digital signal contains two mono channels. For example, if group 1 audio is selected for de-embedding, output 1 contains channels 1 and 2 from group 1, and output 2 contains channels 3 and 4 from group 1.
