
ANDDIZED TRIM PANEL

<u>INSTALLATION</u>

- 1) If standard black powder coat top and bottom trim panels are already installed, remove panel from top and bottom of enclosure (2 hex screws per panel).
- 2) Insert supplied hex screws into anodized trim panel.
- 3) Stack nylon washers onto hex screw shaft (3 washers per screw).

NOTE: Install washers so that teeth face away from panel as shown.

4) Place assembled panel over slots on top and bottom of enclosure and tighten hex screws using provided hex driver until secure. Do not over tighten.
