
REAR BAY EXTENDER INSTALLATION INSTRUCTIONS

NOTES


- If cable tie saddles are installed at the top of the C5 Credenza, they must be removed before installation.
- There are two holes provided on both sides and the top/bottom of the C5 Extender to allow for installation of cable tie saddles. Two tie saddles and mounting hardware are provided with the extender. The tie saddles can be installed on the outside or inside of the extender.
- Cable access is located at the top and bottom of the extender. Cable grommets are factory installed to prevent damage to cabling.
- The extender can be installed in any bay.

INSTALLATION

- 1) If installed, remove the door. Using a 5/16" wrench install the provided screws at the bottom of the C5.



- 2) Place the extender on top of the screws for alignment. Lift the extender slightly and insert the hooks on the inside of the extender into the two slots on the C5.



- 3) Fully tighten the screws at the bottom. A hex driver is recommended to fully tighten the screws.
- 4) Reinstall rear door if you are using one.
