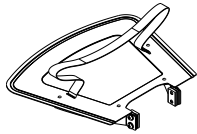

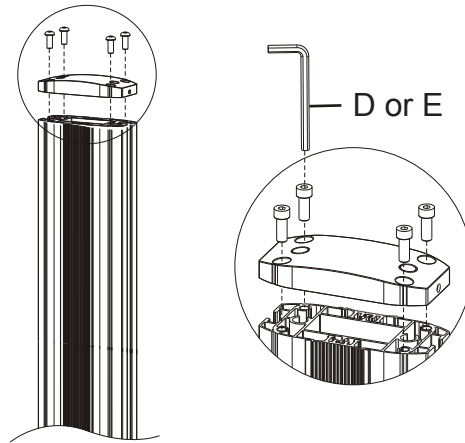

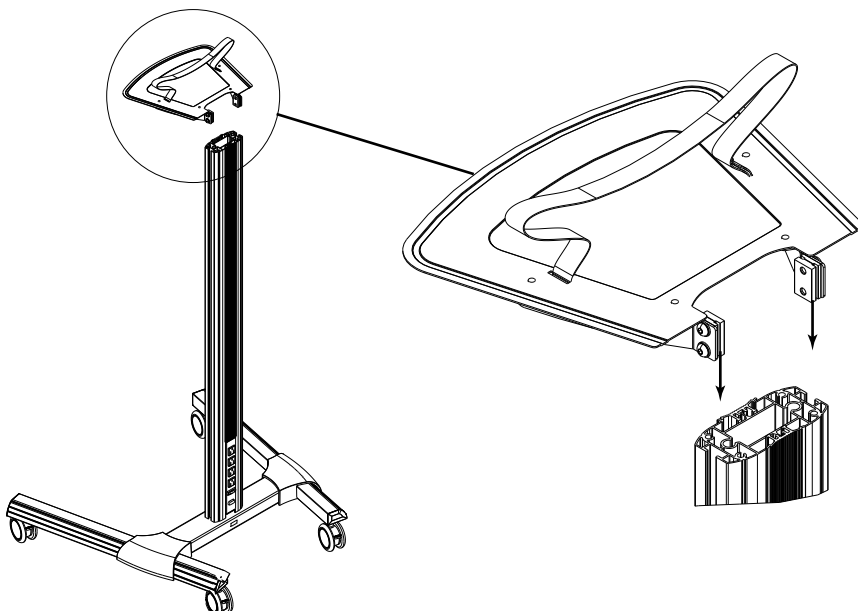
#### INSTALLATION

WEIGHT RATING: 10 lbs.

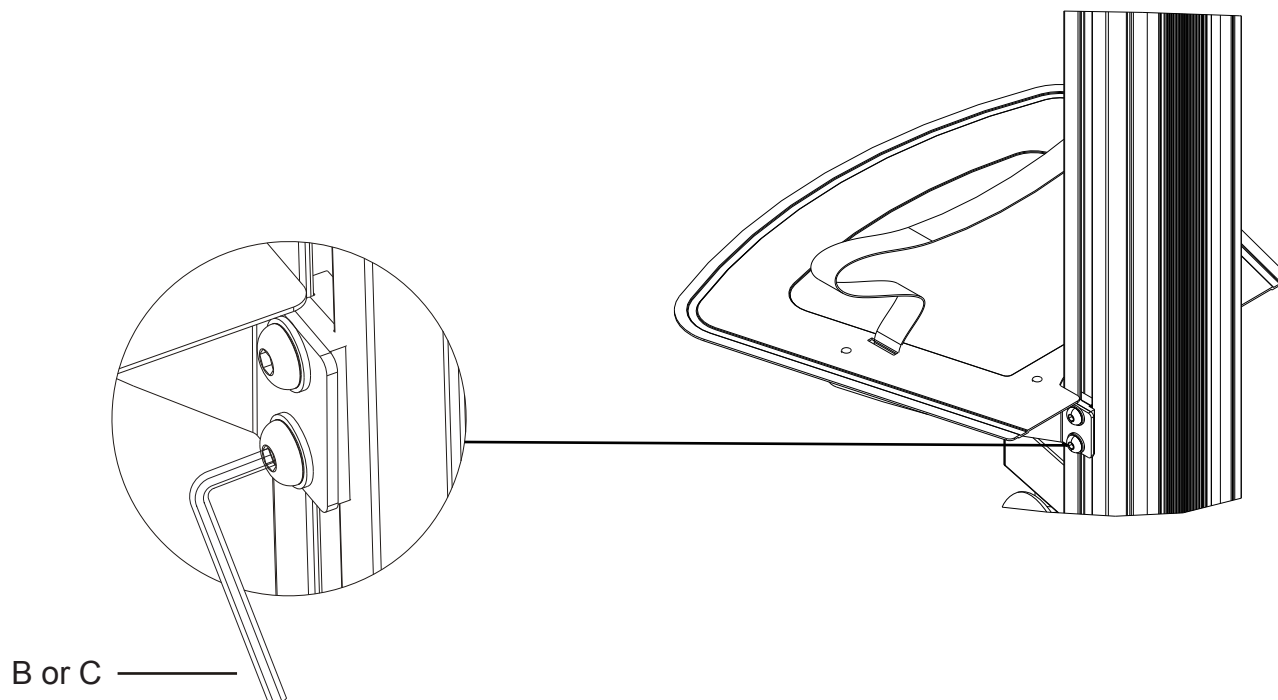
- 1) If already installed, remove the top with a 6mm Hex Key/Bit.



- 2) Slide the shelf into the openings on the upright. If using the monitor mount, it cannot be installed at this time.



3) Slide the shelf to the desired position. Tighten the four screws (2 per side) with a 5mm Hex Key/Bit.
