- 1) Remove rear panel. (FIGURE A)
- 2) For ease of installation, remove (6) screws securing presenter's panel to frame and remove from frame. (FIGURE A)
- 3) If necessary, refer to manufacturer's instructions for additional hookup and operation details.




- 5) Install clock timer using (4) 6-32 flange nuts and (4) 6-32 x 3/8" pan head Phillips screws. **(FIGURE B)**
- 6) Re-install presenter's panel in reverse manner.
- 7) Re-install rear panel.
