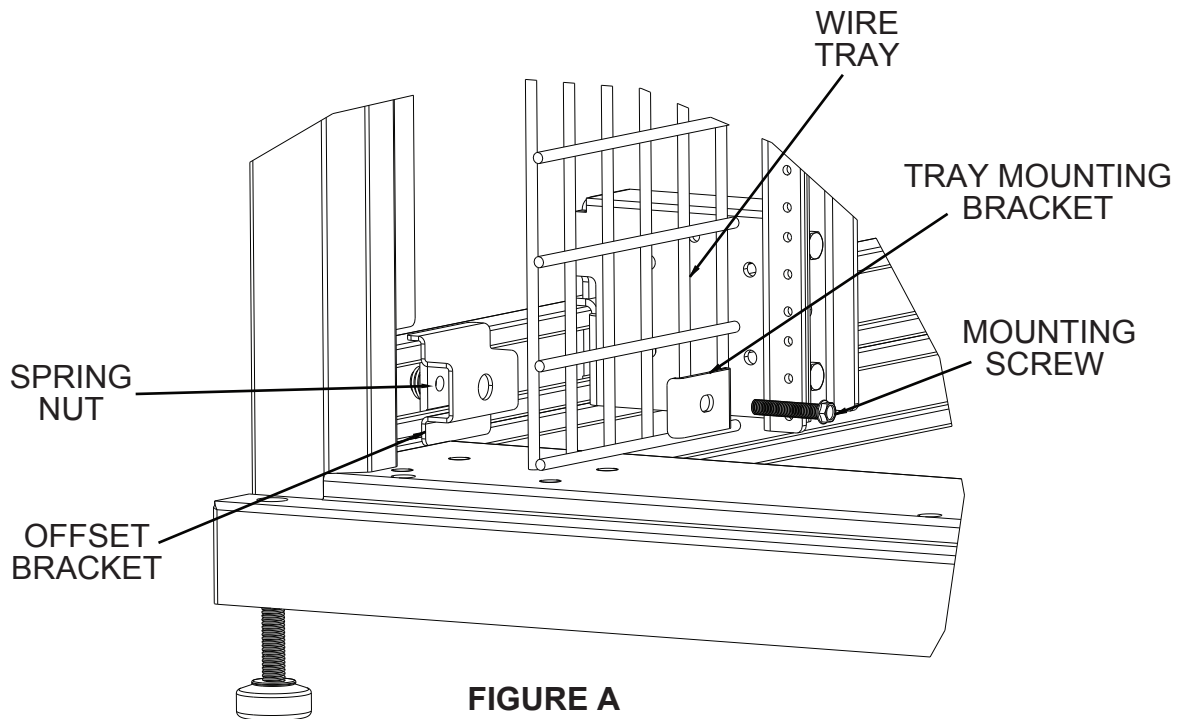

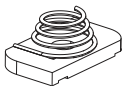
## INSTALLATION TO CHANNEL

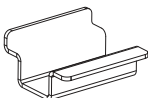

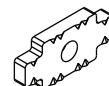

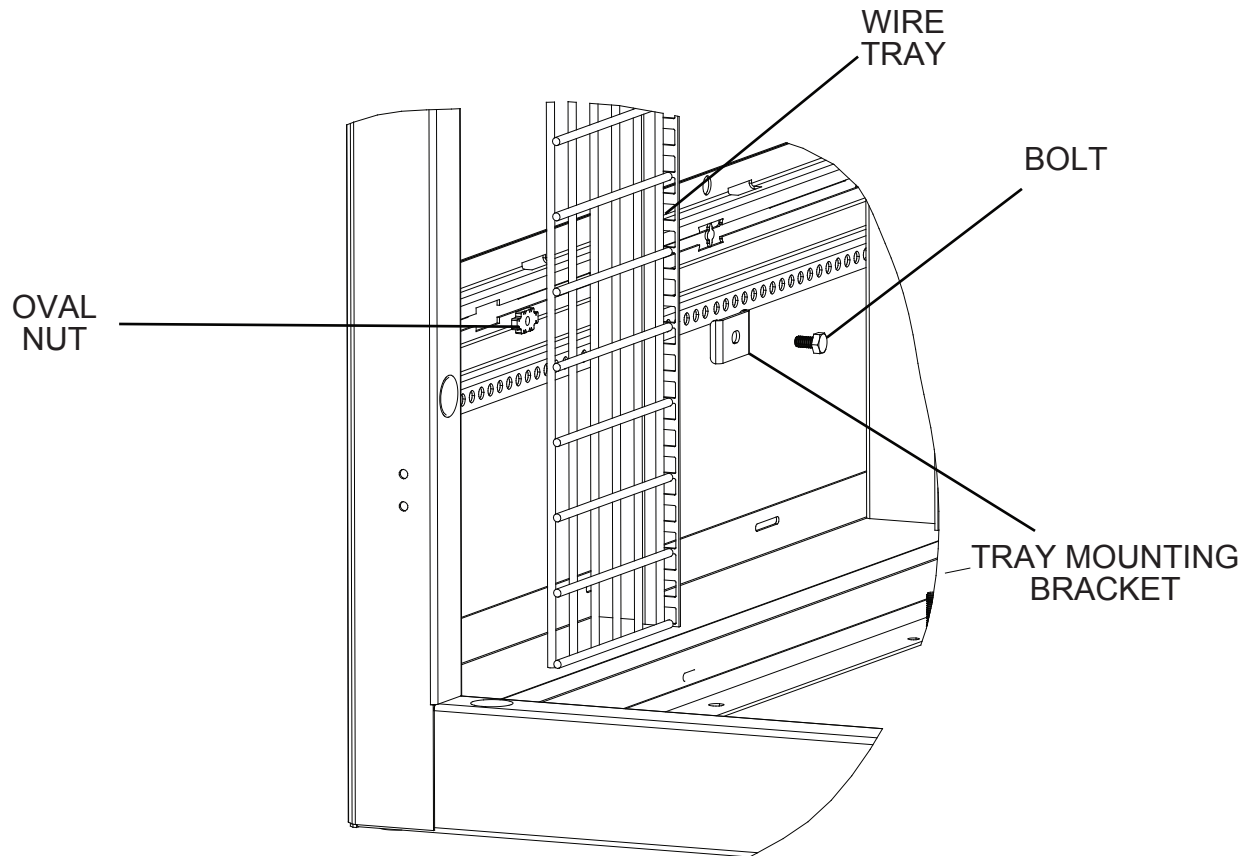
