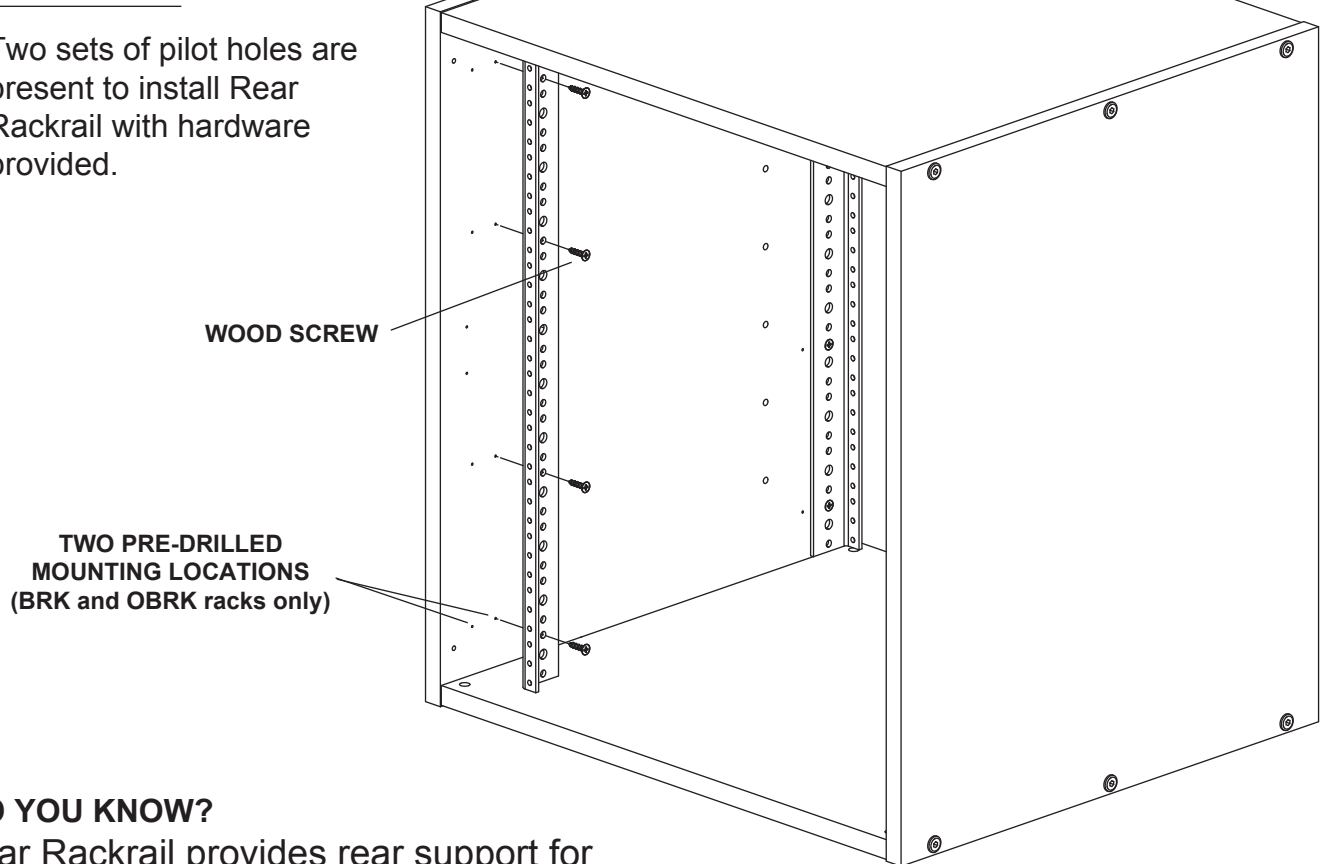


WOOD SCREW #8x5/8

TIP: Installation is easier prior to assembly of rack, but Rear Rackrail may be installed after assembly if necessary.

- 1) Two sets of pilot holes are present to install Rear Rackrail with hardware provided.
