





NOTE: The cable duct can be mounted to either rack channel front hole or rear hole, depending on the setback of the duct required. Extra hardware is provided so that cable duct can be ganged between two racks.

1) Align cable duct top hole with rack hole and install one (1) threaded stud and flange nut as shown.

NOTE: Aligning holes at top of rack and Cable Duct aligns the other two hole locations.

2) Install one (1) threaded stud and flange nut at remaining locations as shown. Tighten all locations.


