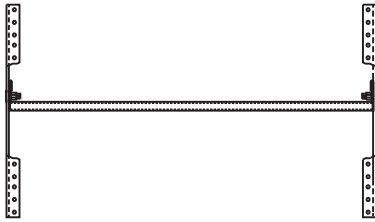

NOTE: If using on a SLIM 5 with the cable chase installed, the cable chase must be removed before installing the rackshelf.

- 1) Determine the type of mounting. (FLANGE UP or FLANGE DOWN)



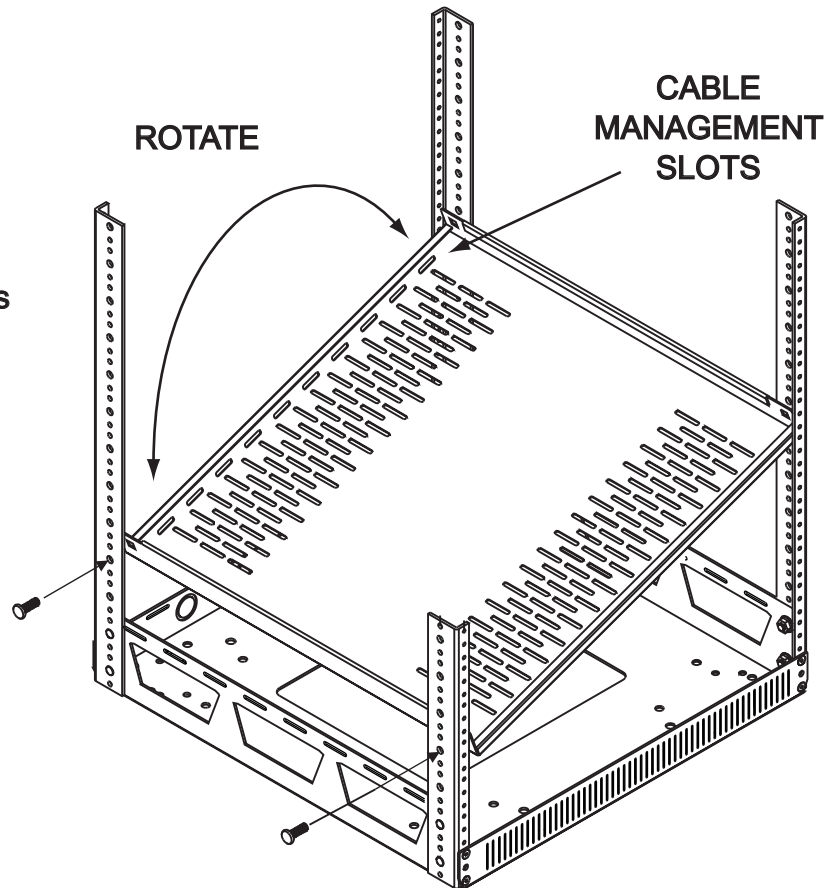
FLANGE UP

- OR -

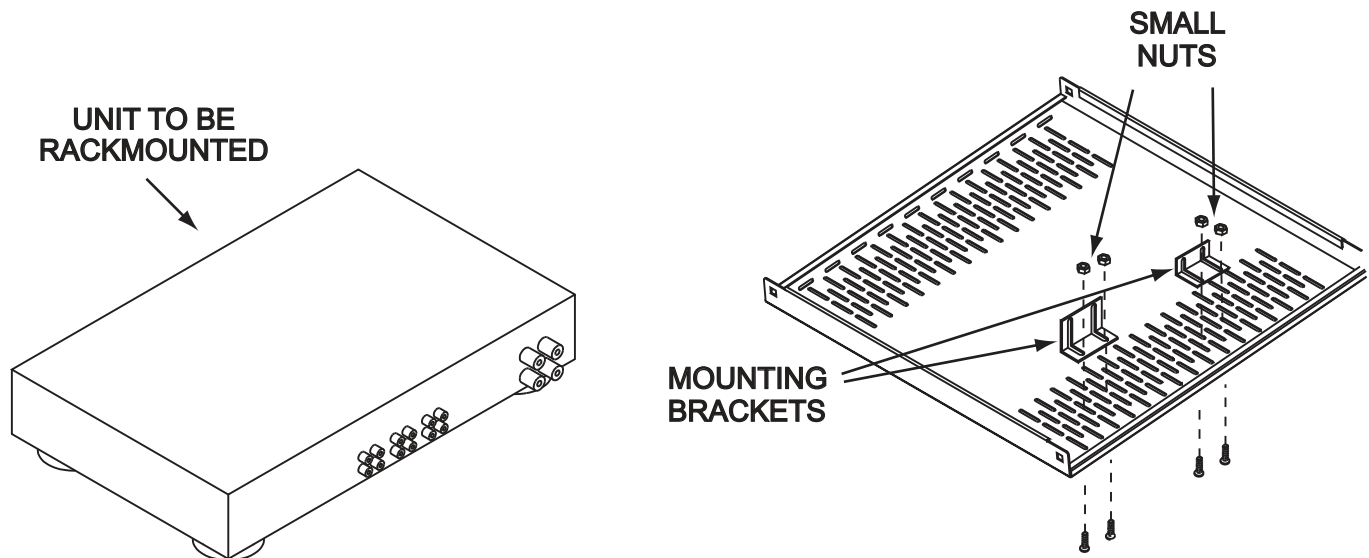


FLANGE DOWN

- 3) Secure with the large studs and nuts provided.
