

Installation

Notes:

- 1. Test to make sure the entire installation works properly before pulling cables through ceilings/walls.
- 2. The P166-001-A has been designed for use with Tripp Lite P568-Series HDMI cables. To ensure maximum distance and performance, it is recommended that you use Tripp Lite P568-Series HDMI cabling.
- 1 Connect the longer HDMI cable between the source and the INPUT port on the back of the P166-001-A.

Note: When transmitting a 1080p (24Hz) signal, the HDMI cable connecting the source to the P166-001-A must be no longer than 150 ft. For distances over 75 ft., use 24AWG HDMI cable, such as P568-100-HD.



2 Connect an HDMI cable from the front of the P166-001-A to your monitor.

Note: the HDMI cable connecting the P166-001-A to the monitor must be no longer than 16 ft. (5 m).
