


# FOR 29, 37, 43 SPACE MODELS ONLY

### **ASSEMBLY**

1) Attach the 4 rackrails to the top and bottom using the flange nuts (DO NOT TIGHTEN) and #10-32 flathead Allen screws (TIGHTEN FIRMLY). (FIGURE A)

NOTE: Ensure Cable Pass-through knockouts, top and bottom, are on the same side.






## **ASSEMBLY**

4) Lay the rack on a flat surface and tighten all of the flange nuts. (DO NOT OVERTIGHTEN). (FIGURE D)

NOTE: Rack must be laid on a flat surface to prevent the assembled rack frame from going cubically out of square.



5) Install trim panels to top and bottom using #10-32 flathead Allen screws (DO NOT OVERTIGHTEN). (FIGURE E)


