



### **ASSEMBLY**


1) Place bottom on top of ear, aligning oval holes.



Three (3) Rear Brackets are provided to prevent unit from sliding back. (There are four ways brackets can be mounted)








NOTE: In most cases, rackshelf faces CAN NOT be used with KD bottoms.
