

PHCM SERIES HORIZONTAL CABLE MANAGERS HINGE CLIP AND COVER INSTALLATION

INSTALLATION

1) Slide the hoop section onto the Cover as shown. (FIGURE A)



- 2) It is recommended that you space two clips approximately 5" apart on the cover.
- 3) Once the clips are attached to the cover, snap the clip to the fingers. Attach to one finger at a time. (FIGURE B)
