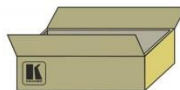
## 106 Quick Start Guide

### Step 1: Check what's in the box

- ✓ 106 Mic Amplifier/DA
- ✓ 1 Power supply (12V DC)

- ✓ 4 Rubber feet
- ✓ 1 Quick Start sheet



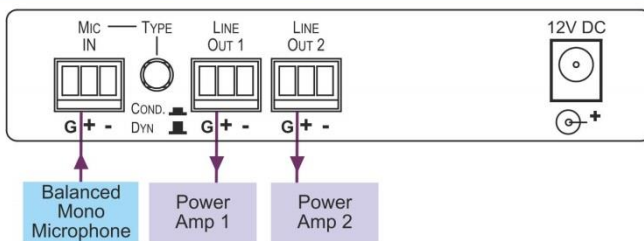
Save the original box and packaging materials in case you need to return your **106** for service.

### Step 2: Install the 106

Attach the rubber feet and place on a table or mount the **106** in a rack (using an optional **RK-3T** rack mount).

### Step 3: Connect the inputs and outputs

Always switch off the power on each device before connecting it to your **106**.



Always use Kramer high-performance cables for connecting AV equipment to the **106**.

### Step 4: Connect the power

Connect the 12V DC power adapter to the **106** and plug the adapter into the mains electricity.



### Step 5: Operate the 106

Adjust the line out audio level with a small screwdriver.

## 2 Getting Started

We recommend that you:

### 2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables (we recommend Kramer high-performance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality
- Position your Kramer **106** away from moisture, excessive sunlight and dust



This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.

## 2.2 Safety Instructions



**Caution:** There are no operator serviceable parts inside the unit

**Warning:** Use only the Kramer Electronics input power wall adapter that is provided with the unit

**Warning:** Disconnect the power and unplug the unit from the wall before installing

## 3 Overview

The **106 Mic Amplifier / DA** is a high-quality distribution amplifier for balanced mono microphone signals. It takes one dynamic or condenser microphone input and distributes the signal to two high-level balanced mono line outputs, reaching 27Vpp (22dB).

The **106** features:

- Three trimmers to adjust the LINE OUT audio level
- A switch for selecting the type of microphone (condenser or dynamic)
- Two balanced mono line outputs for power amplifiers

### 3.1 Defining the 106 Mic Amplifier/DA

This section defines the **106**.

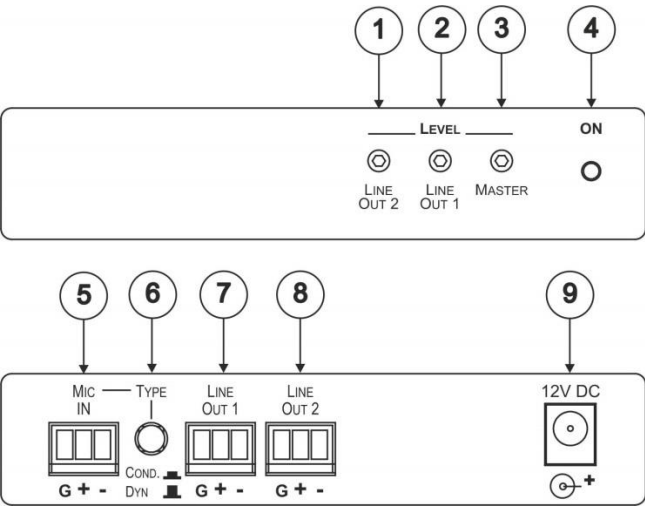


Figure 1: 106 Mic Amplifier/DA

## 4 Connecting the 106



Always switch off the power to each device before connecting it to your **106**. After connecting your **106**, connect its power and then switch on the power to each device.

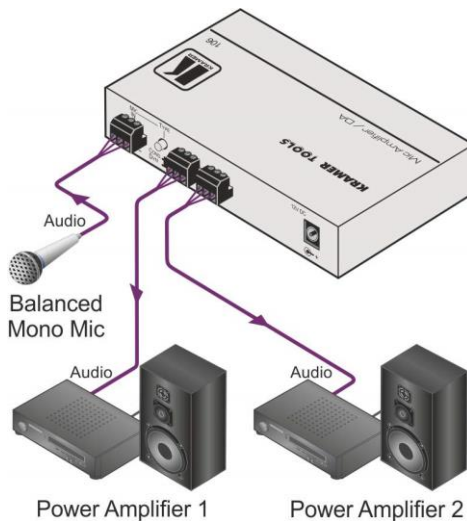


Figure 2: Connecting the 106 Mic Amplifier/DA

To connect the **106** as illustrated in the example in [Figure 2](#):

1. Connect a mono balanced microphone to the MIC IN terminal block connector.
2. Connect the LINE OUT 1 terminal block connector to a power amplifier and/or the LINE OUT 2 terminal block connector to a power amplifier.
3. Connect each power amplifier to a loudspeaker.
4. Connect the 12V DC power adapter to the power socket, and connect the adapter to the mains electricity.
5. Adjust the audio level via LEVEL trimmers, if required.  
Use the LINE OUT 1 trimmer to adjust the line 1 output, use the LINE OUT 2 trimmer to adjust the line 2 output, and use the MASTER trimmer to adjust both line outputs.
