- Avoid interference from neighboring electrical appliances that may adversely influence signal quality.
- Position your Kramer VM-22H away from moisture, excessive sunlight and dust.

Overview

Congratulations on purchasing your Kramer VM-22H 2x1:2 HDMI Switcher/DA. The VM-22H is a distribution amplifier for HDMI™ signals. The unit reclocks and equalizes one of two selectable input signals and distributes it to two identical outputs.

In particular, the **VM-22H** features:

- A maximum data rate of 6.75Gbps (2.25Gbps bandwidth per graphic channel.
- I-EDIDPro™ Kramer Intelligent EDID Processing™, an intelligent EDID handling and processing algorithm that ensures Plug and Play operation for HDMI systems.
- Kramer Equalization & re-Klocking™ Technology that rebuilds the digital signal integrity to travel longer distances.
- 3D pass-through.
- HDMI support for Deep Color, x.v.Color™, Lip Sync, CEC.
- HDCP compliance.
- Selected input and active output LED indicators.

Typical Applications

This section defines the VM-22H.




Figure 1: VM-22H 2x1:2 HDMI Switcher/DA

#	Feature	Function
1	5V DC	+5V DC connector for powering the unit.
2	HDMI OUT2 Connector	Connects to the HDMI acceptor 2.
3	HDMI OUT1 Connector	Connects to the HDMI acceptor 1.
4	HDMI IN 2 Connector	Connects to the HDMI source 2.
5	HDMI IN 1 Connector	Connects to the HDMI source 1.
6	REMOTE IR	The yellow LED illuminates when receiving signals from the infrared remote control transmitter.
7	EDID SETUP Button	Press briefly to determine the type of EDID stored in the non-volatile memory. Press and hold to select the desired EDID setup and then release to acquire EDID (see <u>Acquiring the EDID</u> on page <u>7</u>).
8	IN SELECT Button	Press to select the input. The relevant IN LED illuminates.
9	IN 1 LED	Illuminates when input 1 is selected.
10	IN 2 LED	Illuminates when input 2 is selected.
11	OUT 1 LED	Illuminates when output 1 is connected and active (also illuminates or blinks during EDID setup, see Acquiring the EDID on page 7).
12	OUT 2 LED	Illuminates when output 2 is connected and active (also illuminates or blinks during EDID setup, see Acquiring the EDID on page 7).
13	ON LED	Illuminates when receiving power.

Mounting VM-22H

This section provides instructions for mounting **VM-22H**. Before installing, verify that the environment is within the recommended range:



- Operation temperature 0° to 40°C (32 to 104°F).
- Storage temperature -40° to $+70^{\circ}$ C (-40 to $+158^{\circ}$ F).
- Humidity 10% to 90%, RHL non-condensing.



Caution:

• Mount VM-22H before connecting any cables or power.



Warning:

- Ensure that the environment (e.g., maximum ambient temperature & air flow) is compatible for the device.
- · Avoid uneven mechanical loading.
- Appropriate consideration of equipment nameplate ratings should be used for avoiding overloading of the circuits.
- Reliable earthing of rack-mounted equipment should be maintained.

To mount the VM-22H on a rack

Mount the unit in a rack using the recommended rack adapter (see www.kramerav.com/product/VM-22H)

To mount the VM-22H on a table or shelf

- Attach the rubber feet and place the unit on a flat surface.
- Fasten a bracket (included) on each side of the unit and attach it to a flat surface.

Connecting the VM-22H



Always switch off the power to each device before connecting it to your VM-22H. After connecting your VM-22H, connect its power and then switch on the power to each device.




Figure 2: Connecting the VM-22H 2x1:2 HDMI Switcher/DA

To connect the VM-22H as illustrated in the example in Figure 2:

- 1. Connect the HDMI source (for example, a DVD player) to the HDMI IN 1 connector.
- 2. Connect the HDMI source (for example, a DVD player) to the HDMI IN 2 connector.
- 3. Connect the HDMI OUT connectors to up to two HDMI acceptors, as follows:
 - HDMI OUT 1 connector to an LCD TV.
 - HDMI OUT 2 connector to a plasma display.
- 4. Connect the 5V DC power adapter to the power socket and connect the adapter to the mains electricity.
- 5. Press the EDID SETUP button to acquire or change the EDID information (see <u>Acquiring</u> the EDID on page 7).

Acquiring the EDID

This is usually done only once, when the machine is being set up in an installation. Once acquired, the EDID is saved in non-volatile memory and further acquisition is not necessary.

Initially, the **VM-22H** operates with the factory default EDID. This lets you connect the power before connecting one of the acceptors or sources.

You can acquire the EDID from:

- One output (the relevant output illuminates).
- The default EDID (both output LEDs blink).
- Two connected outputs, the auto-mix mode (both output LEDs illuminate).



The EDID acquired is a weighted average of all the connected outputs. For example, if several displays with different resolutions are connected to the outputs, the acquired EDID supports all the resolutions, as well as other parameters included in the EDID.

When pressing the EDID SETUP button briefly, the OUT LEDs indicate which type of EDID was last acquired. If the:

- OUT 1 LED illuminates, the OUT 1 EDID is stored in the non-volatile memory.
- OUT 2 LED illuminates, the OUT 2 EDID is stored in the non-volatile memory.
- OUT 1 and OUT 2 LEDs blink, the Default EDID is stored in the non-volatile memory.
- OUT 1 and OUT 2 LEDs illuminate, the Auto-Mix EDID is stored in the non-volatile memory.

To acquire the EDID, do the following:

- 1. Connect the power.
- 2. Connect the output or outputs from which you want to acquire the EDID.
- Press and hold the EDID SETUP button to select the desired EDID.
 The OUT LEDs illuminate in the following cycle: OUT 1, OUT 2, both flash (default) and both illuminate (auto-mix).
- 4. Release the button when reaching the desired set up. The EDID is now acquired.



If you set the machine to acquire the EDID from an output that is not connected, the default EDID is acquired.

How Long this Coverage Lasts

The standard limited warranty for Kramer products is seven (7) years from the date of original purchase, with the following exceptions:

- 1. All Kramer VIA hardware products are covered by a standard three (3) year warranty for the VIA hardware and a standard three (3) year warranty for firmware and software updates; all Kramer VIA accessories, adapters, tags, and dongles are covered by a standard one (1) year warranty.
- 2. All Kramer fiber optic cables, adapter-size fiber optic extenders, pluggable optical modules, active cables, cable retractors, all ring mounted adapters, all Kramer speakers and Kramer touch panels are covered by a standard one (1) year warranty.

What Kramer Electronics Will Do

Kramer Electronics will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

- 1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. Kramer Electronics will also pay the shipping costs necessary to return this product once the repair is complete.
