

This product ships upside down. Tip the side rack on its back when removing it from box. Tipping the side rack carefully onto excess cardboard will help prevent scratches or marks.





ASSEMBLY

NOTE: If attaching a desk to both sides, skip to STEP 3




2) Attach the trim to the bracket as shown. Do not tighten screws until trim is properly aligned (3 screws, 6 x 1/2 Truss Head). The tab on the side rack goes into the slot in the trim. Add grommets as desired.




ASSEMBLY (Continued)

3) Remove the side panel from the desk if one is present. Line up the mounting holes on the desk with the pilot holes on the LD-12 Side Rack. The tab on the side rack goes into the slot in the desk trim. Anchor the LCD Monitoring Desk to the LD-12 Side Rack as shown.

(3 screws, 10 x 5/8 Truss Head)




4) The front door can be changed to open from the other side. Remove screws and flip the door before re-installing to opposite side. Align the door before tightening the screws.



ACTIVE COOLING CONFIGURATION

Protect sensitive equipment using advanced thermal management. Place the provided vent blockers inside the rack to cover the front and rear vents. Remove the 2 space vent panel on the rear door and install the optional UQFP Series Fan Panel. (UQFP-4 shown)



CABLE MANAGEMENT

Use the grommets and holes on the LD-12 Side Rack to conceal cables.
