The MPR-SS Transient voltage surge suppressor is a self contained module that contains three (3) metal oxide varistors, and a capacitor to suppress surges, spikes and EMI noise.


ASSEMBLY

The MPR-SS mounts inside of the J-Box of any MPR Series raceway, and is secured to the inside of the J-Box cover using supplied double-stick tape.

Connect the wiring as shown in the diagram using "wire nuts" or other wire connectors that are intended for the use indicated.

The colors of the wires, extending from the MPR-SS are to be connected to the field wiring (feed) as follows:
White: To system NEUTRAL
Red: To system LINE (hot)

If multiple circuits are used, a separate MPR-SS must be installed on each circuit.


