

Thank you for purchasing the PRX-WB-14X14 or PRX-WB-9X14 Proximity Series In-Wall Box. Please read these instructions thoroughly before installing or assembling this product.

PRODUCT FEATURES

- Provides storage of AV components and power that can be hidden behind a wall-mounted display.
- Available in 14" x 14" (PRX-WB-14X14) or 9" x 14" (PRX-WB-9X14) sizes designed to fit between adjacent wall studs aligned to 16" centers.
- Knockouts provided for power and cable management.
- Total Weight Capacity: 15 lbs.



REQUIRED TOOLS

- No. 2 Phillips Driver
- Utility Knife
- Level With Ruler Edge
- Hammer
- Pencil
- Stud Sensor
- Power Drill
- 1/4" Drill Bit

PLANNING CONSIDERATIONS

1. If installing the in-wall box (A) to bare studs (prior to drywall installation), extra care should be taken when finishing the wall around the box opening. Install the trim ring after drywall is completed.
2. The box is meant to be installed between wall studs. Identify the desired box location in the room. A stud sensor may be necessary to identify and mark the wall studs.
3. Consider how many devices are going to be mounted inside the box and where they will be positioned.
4. Knockouts on the box should be cleared prior to installation and based on your signal connection and power needs.
5. Identify existing electrical, plumbing, gas lines, and HVAC structural issues and prepare any necessary cable routing in advance with a qualified technician.

CUTTING DRYWALL OPENING FOR THE BOX (IF NECESSARY)

1. Identify the desired location of your box between adjacent wall studs. Use a stud sensor and mark the location of the studs with a pencil.
2. Use a level and pencil to make a horizontal line between the two studs to mark the bottom opening for the box.
3. Confirm the stud locations by carefully drilling a small hole on each side where the horizontal line meets the mark made for the stud.

CUTTING DRYWALL OPENING FOR THE BOX (IF NECESSARY, CONTINUED)

4. Use the back of the box as a template to draw lines along tops and sides. Align the box to the lower corner (where the stud meets the horizontal line) and use a level on the top of the box to ensure correct alignment when drawing lines.

NOTE: A larger opening may be necessary to accomodate conduit connectors (not provided) grommets, and the included F7526-V1 duplex outlet power kit when attached to the box.

5. Use a utility knife to cut the opening for your box and carefully remove the drywall.

NOTE: The trim ring provides 5/16" coverage around the opening and may be used to hide minor drywall blemishes. (**FIGURE A**)



REMOVING THE TRIM RING

1. Remove (4x) trim screws (B) to take the trim ring off the box as shown. (**FIGURE B**)



CABLING THROUGH THE TOP OF THE BOX



WARNING: All wiring should be installed by a licensed electrician following all local codes and ordinances.

1. Use a hammer to knock out the top cable holes required to accommodate the devices you plan on installing in the box. (**FIGURE C**)



2. Prepare all signal cables for passing through knockouts when mounting the box to the wall studs.

NOTE: Any punched openings not in use must be sealed with a suitable plug. Covers or panels that are removed must be replaced and secured.

RUNNING POWER TO THE BOTTOM OF THE BOX



WARNING: All wiring should be installed by a licensed electrician following all local codes and ordinances.

1. Use a hammer to knock out the electrical box rectangles and the hole to accommodate your power needs for the devices you plan on installing in the box. (**FIGURE D**)



2. Prepare all power cables for passing through knockouts when mounting the box to the wall studs.

NOTE: Any punched openings not in use must be sealed with a suitable plug. Covers or panels that are removed must be replaced and secured.

MOUNTING THE BOX TO WALL STUDS

1. Set the box between the wall studs through the drywall (if applicable). (**FIGURE E**)



2. Feed any cabling through their corresponding knockouts on the box.
3. Use a 1/4" bit to drill pilot holes through the mounting holes from the inside of the box, if desired.
4. Mount the box to the studs using (4x) #10 x 1 1/2" (minimum size) wood screws and (4x) #10 washers (screws and washers not provided) through the mounting holes from the inside of the box. (**FIGURE F**)



MOUNTING THE BOX TO WALL STUDS (CONTINUED)

5. Attach any grommets (not provided) to the box, as desired.
6. Pass signal and power cables through all knockouts on the box.
7. Remove and discard any pre-installed screws from the Decora outlet prior to installation. (**FIGURE G**)
8. From the inside of the box, secure the included F7526-V1 duplex outlet power kit's junction box (C), Decora outlet (D), and plate (E) to the desired location using the (4x) J-Box screws (F) as shown. (**FIGURE H**)



NOTE: Holes fit 1 3/4" grommets (not provided).



GROUNDING AND BONDING

A Protective Earth Terminal (PET) is located on the bottom frame of the enclosure. Protective earth and bonding connections shall be in accordance with Article 250 of the National Electric Code. When removing any bonded accessory for servicing the enclosure, make sure to disconnect the bonding terminal from the accessory. **NOTE:** The bonding terminal MUST be reconnected to the accessory when the part is replaced after servicing.

The main protective earth ground needs to be the first terminal placed on the PET and this terminal needs to be secured on its own using the ground screw (G) as shown. (**FIGURE J**)

NOTE: Outlet and junction box removed from subsequent views for clarity.



INSTALLING OPTIONAL POWER DIST. UNIT (NOT PROVIDED) TO THE BACK OF THE BOX

NOTE: The clip for the RackLink Compact RLNK-215 (not provided) may be installed in a variety of configurations. The following procedure is meant to provide an example.

1. Use a 10-32 x 1/2" clip screw (not provided, included with your RLNK-215 or PD-215) and a 1/4" washer (H) to attach the clip for the compact to any of the (4x) 10-32 PEM on the back of the box. (**FIGURE K**)



INSTALLING LEVER LOCK PLATES

NOTE: Different sized Lever Lock plates may be used and components may be installed in a variety of configurations. The following procedure is meant to show the 4" Lever Lock plate (B) installation to get you started.

1. Insert the side of the 4" horizontal Lever Lock plate (J) without the clip into the brackets on the back of the box first. Then install the side with the clip until it clicks into place. (**FIGURE L**)



NOTE:

- (20x) Lever Lock plate washers (K) are provided for equipment mounting convenience.
- Lever Lock plates may be installed on the side brackets at 3 different depths. All 4 corners of a Lever Lock plate must be inserted into the side brackets at the same depth in order to function correctly. (**FIGURE M**)



INSTALLING THE TRIM RING

1. Use (4x) trim screws (B) to install the trim ring to the box as shown. (**FIGURE N**)



CONNECTING POWER TO THE F7526-V1 DUPLEX OUTLET



WARNING: All wiring should be installed by a licensed electrician following all local codes and ordinances.

CONNECTING POWER TO THE F7526-V1 DUPLEX OUTLET

1. Remove power.
2. Strip wire insulation to expose end of wire to 3/4".
3. Attach wires as shown. (**FIGURE P**)
4. Tighten terminal screws securely.
5. Use feed-through terminals when wiring to another outlet downstream.
6. Mount outlet (D) as previously shown on page 9. (**FIGURE H**)
7. Restore power only when finished wiring the entire circuit.


