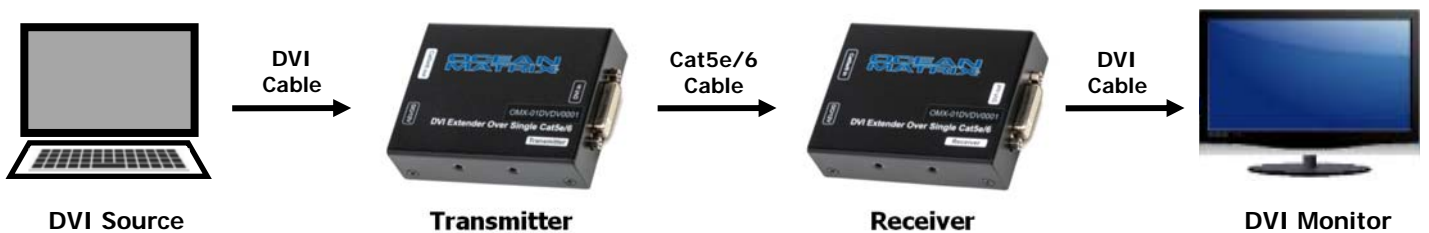

SAFETY PRECAUTIONS
